

# **P-2201 APPLICATION (continued)**

## **P-2201G Application Decisions (Reach Up rule 2216)** **(20-08)**

### **Approval**

Provide eligible households the opportunity to receive benefits as soon as possible, but no later than 30-calendar days from the application date.

Issue a combined benefit when the household:

- applies after the 15<sup>th</sup> of the month, and
- is found eligible for the initial month and the following month.

### **Denial**

Deny the application as soon as possible, but no later than 30-calendar days from the application date for households found ineligible for benefits.

Households must file a new ESD 202 if they wish to receive benefits. Since a signed signature page is considered an application, households can choose to submit a new signed first page of the application, and request that the rest of the information be taken from a previously submitted and acted upon application available in OnBase if the information is still accurate. There is no time limit to how long a previously submitted application can be used, as long as a new signature page is provided.

### **BPS Support**

Before approving eligibility make sure information entered for the current month is carrying forward into future months.

Enter the correct withdrawal or denial code on the STAT C STAT panel. Non-coop codes are used for non-cooperation. These codes will go away after a set period of time. When a new application is entered for a previously closed case these codes will be gone and will not cause an automatic denial.

Use "N" for not providing verification and "I" for not completing an interview.
