

P-2210 HOUSEHOLD COMPOSITION (continued)

P-2210G Mandatory Youth (Reach Up Services rule 2337)

Inform District Management team if 16 or 17 year old child in the Reach Up household is no longer a full time student.

Out of school youth (known as Mandatory Youth) are required to work with a Reach Up case manager. If they do not participate, the youth can be sanctioned and their needs will be removed from the Reach Up grant.

If they are the only household member (parent(s) on SSI or child only caretaker grant) the household must be closed.

BPS Support

To remove the Mandatory Youth from the household the case manager or Reach Up Supervisor will have to "sanction" the youth.

Go to CASE C SANC and select the youth (a WORK screen will have to be entered for the youth to show up on the CASE C SANC screen).

Enter a code "M". No meeting information is stored for a mandatory youth.
