

P-2225 RECERTIFICATION (Reach Up rule 2213)

The Review Reminder Letter will be printed automatically by ACCESS. Buildings and General Services (BGS) will send out the Notice with the ESD 202 Application to all households who will be recertified in the next month.

Failure to Complete Required Review

When a household does not complete their required recertification either by not completing an interview, not returning the 202 Application, or not providing requested verification, benefits will end.

Enter the appropriate non-cooperation code before the adverse action deadline for the month of review.
